Judge Kressel has served as a member of the Advisory Committee on Bankruptcy Rules of the Judicial Conference of the United States, the Federal Judicial Center's Bankruptcy Judges Education Committee and the Eighth Circuit's Gender Fairness Task Force. Before becoming a law professor, Maroney was a litigator with WilmerHale and a Skadden Fellow at the Urban Justice Center, both in New York City; she draws on that practice experience—which included a high-profile triple exoneration, U.S. Supreme Court advocacy, and direct representation of children—in her teaching and writing. A 1998 summa cum laude graduate of New York University School of Law,

Maroney clerked for Judge Amalya L. Chief Judge Lavenski R. Smith was nominated to the U.S. Court of Appeals for the Eighth Circuit by President George W. Bush on September 4, 2001, to a seat vacated by Richard S. Arnold. He was confirmed by the

Senate on July 15, 2002 and received his commission on July 19, 2002.

Chief Judge Smith is a lifelong Arkansan. He was born and raised in Hope, Arkansas, and graduated from Hope High School in 1977. Chief Judge Smith earned his bachelor and Juris Doctor degrees from the University of Arkansas at Fayetteville in 1981 and 1987, respectively. He is the son of Cayce B. (deceased) and Olee M. Smith (deceased). He is married to Trendle Smith from Camden, Arkansas, and they have two children, Stacia and Gabriel.

Before joining the federal bench, Chief Judge Smith worked in both private practice and public service. From 1987 to 1991, he served as a staff attorney for Ozark Legal Services. In 1991, he opened a law office in Springdale, Arkansas. He practiced primarily civil law, including domestic relations, probate, workers' compensation, commercial transactions, and real estate. While in private practice, Chief Judge Smith also did civil liberties work through the Rutherford Institute. David Stras became a judge on the United States Court of Appeals for the Eighth Circuit on January 31, 2018. Before serving on the Eighth Circuit, Judge Stras was

an Associate Justice of the Minnesota Supreme Court. Prior to becoming a judge, Stras was a member of the faculty of the University of Minnesota Law School from 2004 through 2010. Judge Stras received his Bachelor of Arts degree, with highest distinction, in 1995 and his Master of Business Administration in 1999, both from the University of Kansas. During that time, he also served as President of the Colorado District Attorney's Association and President of the El Paso County Bar Association.

A lifelong resident of Colorado Springs, Suthers attended grade school here and graduated from St. Mary's High School. He graduated *magna cum laude* from the University of Notre Dame, and in the top quarter of his law school class at the University of Colorado. After graduation, he returned home and became a Deputy District Attorney in Colorado

Springs before spending ten years at the law firm of Sparks, Dix and Enoch.

John's wife Janet also grew up in Colorado Springs, earned her MBA from UCCS and is retired from Agilent Technologies. John and Janet have two accomplished daughters and two beautiful grandchildren.

1994-1998, Judge Tunheim served as Chair of the U.S. Assassination Records Review Board, a federal agency that declassified the remaining secret records of the assassination of President Kennedy. Before his appointment as a judge, he served as Minnesota's Chief Deputy Attorney General, where he argued three cases at the U.S. Supreme Court, and earlier, as Staff Assistant to U.S. Senator Hubert H. Humphrey and Law Clerk for U.S. District Judge Earl Larson. He has devoted much of his judicial career to helping develop the rule of law in new democracies, working in over 40 countries, including drafting the Kosovo Constitution and helping to develop a much-improved legal system in Uzbekistan. Judge Tunheim served for four years as the Chair and ten years as a Member of the U.S. Judicial Conference Committee on Court Administration and Case Management. He is currently a member of the Judicial Conference of the United States and a member of the IT Security Task Force.

He is a graduate of Concordia College and the University of Minnesota Law School, where he served as President of the Law Review. He has served as Chair of the Concordia College Board of Regents and Chair of Advisory Council at the Humphrey School of Public Affairs at the University of Minnesota. The University of Minnesota honored Judge Tunheim in 2010 with its Outstanding Achievement Award. He is a member of the Board

of Directors of the CEELI Institute in Prague and a member of the Executive Committee of the Criminal Justice Section of the American Bar Association.

He is a third generation descendant of Norwegian immigrants and was raised in the northwestern Minnesota farming village of Newfolden. He is married to Kathy Tunheim, CEO of Tunheim, a communications firm in the Twin Cities, father to Liz Tunheim Sheets, a Vice President at Tunheim, and Sam Tunheim, a lawyer in Minneapolis, and grandfather to Isabel Starr Sheets.
