Four years have passed since our last Supreme Court Review during the 2018 Judicial Conference in Nashville. During that time, the Court's calendar has been filled with decisions on topics including separation of power, criminal and civil procedure, the free exercise clause, the Second and Fourth Amendments, and more. Our panelists are Professor Jeffrey Fisher, Co-Director of the Supreme Court Litigation Clinic at Stanford Law School, and Mr. Kannon Shanmugam, Chair of the Supreme Court and Appellate Practice Group at Paul, Weiss. Both have taught Supreme Court advocacy courses for law students and between them, have argued over 75 cases before the Court. They will review past decisions and discuss what is on the docket in the future terms.

10:10 am – 11:10 am Agency Deference in Administrative Law

In 1984, the Supreme Court decided *Chevron v. National Resources Defense Council*, which created the doctrine that courts normally must defer to government agencies' reasonable interpretations when a law's language is ambiguous. Since then, *Chevron* has continued to be the topic of discussion and one of the most cited Supreme Court precedents. This term, the Supreme Court considers whether, through the Clean Air Act, Congress constitutionally authorized the EPA to issue significant rules with virtually no limits on what the agency can require. The Supreme Court's ruling has potential to impact, limit, or even remove the scope of authority Congress can give to the EPA and other federal agencies.

The U.S. Department of Justice's Criminal Division, in partnership with the 93 U.S. Attorneys' Offices, is responsible for developing, enforcing, and supervising the application of nearly all federal criminal laws. In addition to its direct litigation responsibilities, the Criminal Division formulates and implements criminal enforcement policy and provides advice and assistance on criminal matters. The Criminal Division is currently handling matters ranging from advancing accountability for war crimes committed in Ukraine, the January 6 attack on the Capitol, and combatting the opioid crisis – to kleptocracy asset recovery, corporate compliance, and sensitive areas of law enforcement, such as participation in the Witness Security Program and the use of electronic surveillance. Assistant Attorney General Kenneth A. Polite, Jr., who leads the Criminal Division, will discuss these topics and provide an overview of the Division's priorities, policies, and programs.

Sam Quinones Journalist and Author The Least of Us: True Tales of America and Hope in the Time of Fentanyl and Meth

Author Sam Quinones traveled from Mexico to main streets across the U.S. to create his awardwinning *Dreamland*, a groundbreaking portrait of the opioid epidemic that awakened the nation in 2015. As the nation struggled to put back the pieces, new dangers that lay ahead: synthetic drugs and a new generation of kingpins whose product could be made in Magic Bullet blenders. In fentanyl, traffickers landed a painkiller a hundred times more powerful than morphine. They laced it into cocaine, meth, and counterfeit pills to cause tens of thousands of deaths—at the same time as Mexican traffickers made methamphetamine cheaper and more potent than ever. Quinones will discuss his investigation into how addiction is exacerbated by consumer-product corporations. Amid a landscape of despair, Quinones found hope in those embracing the forgotten and ignored, illuminating the striking truth that we are only as strong as our most vulnerable. Weaving analysis of the drug trade into stories of humble communities, his newest book *The Least of Us* delivers an unexpected and aweinspiring response to the call that shocked the nation in *Dreamland*.
